The First 5 Placer Children and Families Commission has a vacancy and is seeking a new members. The Commission was created to develop and implement a strategic plan for local early childhood development and family support programs and to administer the Children and Families Trust Fund. Commission membership is made up of the following:

- persons responsible for management of county functions pertaining to children's services, public health services, behavioral health services, social services, and tobacco and other substance abuse prevention and treatment services
- recipients of project services included in the county strategic plan
- educators specializing in early childhood development
- representatives of a local child care resource or referral agency, or a local child care coordinating group
- representatives of a local organization for prevention or early intervention for families at risk
- representatives of community-based organizations that have the goal of promoting nurturing and early childhood development
- representatives of local school districts
- representatives of local medical, pediatric, or obstetric associations or societies
- One member shall work or reside in the Tahoe region and represent the concerns of that region, **as well as satisfying one of the above criteria.**

The out-going members represented the represented Prevention and Early Intervention for Families at Risk. Although the new member may represent any of the above categories, **preference will be given to a representative of Prevention and Early Intervention for Families at Risk.**

All Commission members are appointed by the Board of Supervisors. Once appointed, the Commission is solely responsible for developing, implementing and evaluating its strategic plan and for administering the Children and Families Trust Fund. The Commission normally meets on the second Thursday of the month from 4:30 to 6:30 p.m. in Auburn. Telephone conferencing may be available

Commission members serve without compensation but are reimbursed the actual amounts of their reasonable and necessary expenses incurred in attending meetings and in performing the duties of their offices. Each Commissioner shall hold office for a term not to exceed three years. Member may serve on the Commission for not more than two consecutive three-year terms.
